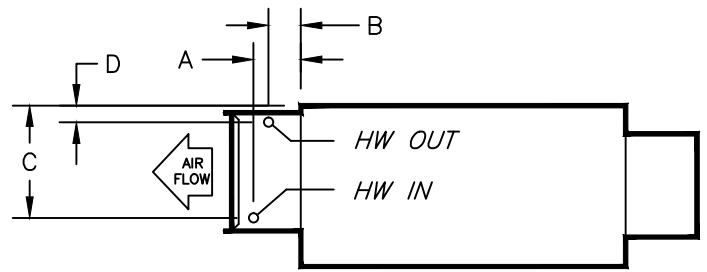


RIGHT HAND HW COIL
